CFS - Prohibition of Milk Brands in the State - Erratum Orders issued.

WHEREAS, regulation 2.1.1(10) of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011 made by the Food Safety and Standards Authority of India in exercise of the powers conferred by clause (i) of sub-section (2) of section 92 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006) read with section 26 thereof, prohibits articles of food in which formalin is added as preservative, as it is injurious to health ;

AND WHEREAS, formalin is added as preservative in milk which is widely used by the general public,

AND WHEREAS, it is expedient to prohibit the following brands in the State of Kerala being food products in which formalin have been detected as preservative vide letter read above

AND WHEREAS, the Commissioner of Food Safety of the State is empowered under Section 30 of the Food Safety and Standards Act, 2006 to prohibit in the interest of public health, the manufacture, storage distribution or sale of any article of food in the whole of State.

NOW, THEREFORE in pursuance of regulation 2.1.1(10) of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011, manufacture, storage, sale or distribution of the above mentioned brands of milk is prohibited in the State of Kerala for one month from date of order in the interest of Public Health. Further extension of period of this ban shall be decided after hearing the parties concerned.

The above read order as (2) above is modified to that extent.

CFS—Prohibition of Milk Brand (KCA Milk) in the State Orders issued.

WHEREAS, regulation 2.1.1(10) of the Food Safety and Standards (Prohibition and Restriction on Sales) Regulations, 2011 made by the Food Safety and Standards Authority of India in exercise of the powers conferred by clause (i) of sub-section (2) of section 92 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006) read with Section 26 thereof, prohibits articles of food in which formalin is added as preservative, as it is injurious to health:

AND WHEREAS, formalin is added illegally as preservative without any justification in milk which is widely sold by the milk firms throughout Kerala.

AND WHEREAS, it is expedient to prohibit the following brand in the State of Kerala being food products, of which samples were taken by special squad constituted vide order read as 1st Paper above, in which formalin has been detected as preservative as per the report of the Research Officer of Mobile Food Testing Laboratory constituted by Commissioner of Food Safety vide order read as second paper above on 24-8-2012, 2.40 a. m. during check post entry surveillance at Neyyatinkara Municipal area.

AND WHEREAS, the Commissioner of Food Safety of the State is empowered under Section 30 of the Food Safety and Standards Act, 2006 to prohibit in the interest of public health, the manufacture, storage, distribution or sale of any article of food in the whole of State.

NOW, THEREFORE, in pursuance of regulation 2.1.1(10) of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011, manufacture, storage, sale or distribution of the “KCA milk, Pasteurized Homogenised Toned Milk”, processed and packed by Milk Products, Industrial Estate, Umayanalloor, Kollam, Pin-691 589 is prohibited in the State of Kerala for one month from date of order in the interest of Public Health. Further extension of period of this ban shall be decided after hearing the parties concerned.
