Certified that I **Jaya.I** duly appointed under the provisions of Food Safety and Standards Act, 2006 (34 of 2006), for **all the Local Areas of the State** received from **Food Safety Officer, Ettumanoor Circle**, a sample of **Beef fry (Collected from Adichira)** bearing Code number **1148** and Serial Number (Not mentioned in Form VI Memorandum) of the Designated Officer of **Kottayam** District on **Twenty Sixth day of August 2014** by courier for analysis.

The condition of seals on the container and the outer covering on receipt was as follows:

The seals fixed on the container and outer cover of the sample were tallied with the specimen impression of the seal send separately with a copy of memorandum in a sealed cover by the Food Safety Officer. The seals are found correct and intact.

I found the sample to be **Beef fry (proprietary Food)** falling under Regulation No. **2.12.1** of FOOD SAFETY AND STANDARDS (FOOD PRODUCTS STANDARDS AND FOOD ADDITIVES) REGULATIONS, 2011. The sample was in a condition fit for analysis and has been analysed on **29/8/14** and completed on **3/9/14** (give date of starting and completion of analysis) and the result of its analysis is given below/ ~~was not in a condition fit for analysis for the reason given below:~~
