The condition of seals on the container and the outer covering on receipt was as follows:-

The seals fixed on the container and the outer cover of the sample were tallied with the specimen impression of the seal sent separately with a copy of memorandum in a sealed cover by the Food Safety Officer. The seals are found correct and intact.
