Explanatory Note

- I The areas of Jurisdiction of the notified Food Safety Officers are restricted to the concerned circle/area of the Mobile Vigilance Squad where they are presently working.
- II According to sub section 1 of section 37 of FSS Act 2006 the Commissioner of Food Safety shall by notification in the official gazette appoint such persons as he thinks fit having the qualification prescribed for such local areas as it may assigned to them.

So each Food Safety Officer need to be notified on fresh appointment/transfer. This creates a vacuum in the implementation of the Act every time a Food Safety Officer is appointed as fresh or transferred from one area of jurisdiction to another. Hence the Food Safety Officers are notified for the entire State. But their jurisdiction restricted to Circle/Municipalities/Corporation as specified in local area notified under Section 3(1)(zb) of Food Safety and Standards Act. This notification is intended to achieve the above object.
