**CFS – Adulteration in coconut oil – proceedings under Section 29(3), 30(1) & 30(2)(d) of Food Safety and Standards Act 2006 - Orders issued - reg.**

**Order No.B1-10825/19/CFS Dated 30.01.2020.**

---

The Food Safety Officers of this department had collected samples of coconut oil from different parts of the State and got them tested in State Food Testing Laboratories and the results are attached as Annexure I. The manufacturers of the coconut oil brands listed in the appendix have violated the provisions contained in Food Safety and Standards Act 2006, Rule 2011 and Regulations made under. Some of the brands of the coconut oil have been prohibited by the Designated officers of the concerned districts and the prohibited food products are distributed and sold in some other districts in violation of the prohibition order. The analytical reports corresponding to the ban order and other test reports received from the Food Analysts have also been verified.

Section 18(1)(a) stipulates that

*“18. The Central Government, the State Governments, the Food Authority and other agencies, as the case may be, while implementing the provisions of this Act shall be guided by the following principles namely :- (1)(a) endeavour to achieve an appropriate level of protection of human life and health and the **protection of consumer’s interests**, including fair practices in all kinds of food trade with reference to food safety standards and practices.”*

And whereas Section 26(2)(ii) stipulate that

*“No food business operator shall himself or by any person on his behalf manufacture, store, sell or distribute any article of food which is misbranded or substandard or contains extraneous matter”*

And whereas Section 27(1) stipulate that

*“The manufacturer or packer of an article of food shall be liable for such article of food if it does not meet the requirements of this Act and the rules and regulations made thereunder”*

Examining the ban orders issued by the Designated Officers along with corresponding analytical reports, the prohibition orders issued by the Designated Officers under Section 36(3)(b) of Food Safety and Standards Act 2006 is upheld. Violation of a prohibition order issued by a statutory authority is a serious threat to public health and a huge food safety risk to general public.

The Commissioner of Food Safety has been entrusted and has been called to perform such function under Section 30(2)(d). To ensure an efficient and uniform implementation of the standards and other requirements as specified and also ensure a high standard of objectivity, accountability, practicability, transparency and credibility,

And therefore in order to protect consumer interest, **the manufacture, storage, sales and distribution of the Coconut oil brands listed as Appendix are prohibited with immediate effect** as envisaged under Regulation 2.1.1(5) of Food Safety and Standards (Prohibition and Restriction on Sales) Regulations 2011, within the State of Kerala. The lifting of the ban shall be subject to further inspections and analysis if represented by the Food Business Operator with supporting documents within 45 days from the date of this order

The ban order issued by the Designated Officers of the concerned districts and other test reports received from the Food Analysts of State Food Laboratories reveal the rampant adulteration prevailing in the sector and therefore Assistant Commissioners shall continue the surveillance across all districts.


