AMC/CMC rate will be considered for calculation of L1.

2. Bids and tender documents, signed physically/ digitally with a valid Digital Signature Certificate, are to be submitted online only in the designated covers on the web portal http://www.etenders.kerala.gov.in

3. Bid should be uploaded only in the specified BOQ form available on the web portal against this tender. Tender, which are not in the prescribed BOQ form are liable to

be rejected.

- 4. An agreement in the prescribed form should be signed by the Tenderer in the Kerala stamp paper of worth Rs. 200/- A specimen form of agreement is given in the tender documents. Hard copy of this agreement should be sent to the tender inviting authority so as to reach it before the date and time of receipt of tenders; otherwise the tenders are liable to be rejected.
- 5. Online opening of the tenders will be carried out on the specified date and time through the official portal http://www.etenders.kerala.gov.in
- 6. Quoted items must comply with respective specifications mentioned in the documents uploaded as 'specifications PDF'.
- 7. The supply and installation shall be effected as the The Government Analysts' Laboratory Thiruvananthapuram, otherwise specified in the 'specifications PDF' of the respective item.
- 8. The successful tenderer should supply the materials on or before the date specified in the purchase order.
- 9. The tender inviting authority will have the power to increase or reduce the number/ quantity of items proposed to be purchased.
- 10. The Tender inviting authority will not be responsible for any sort of delay or difficulty faced during the submission of bids through online by the bidders.
