The declaration of probation depends upon the character and performance of duty, A pass in Account Test for Executive Officers, enrolment in NPS, subscription to GPF, SLI, GIS etc. and other qualification as prescribed if any by the Government from time to time. The Identity Certificates in original duly verified by the Kerala Public Service Commission and the Verification Certificate issued by the Kerala Public Service Commission, shall be **pasted** in the Service Book of the incumbents. Necessary entries regarding the details of the Verification Certificate and service regularisation shall also be made in the Service Book of the incumbents with proper attestation.

The Head of the respective Offices should move this office to get declare the satisfactorily completion of probation or otherwise as and when it comes do.

Second annual increment will be sanctioned only after the declaration of probation.
