The concerned Assistant Commissioners should verify the appeals and those deserving consideration should be forwarded to the Commissioner of Food Safety with copies of the supporting documents within the said period.

Court orders directing to consider the claim of incumbents in General transfer 2020 should compulsorily forwarded. The Appeal should be forwarded through online in the following mail address.
