An agreement in the prescribed form should be signed by the Tenderer in the kerala stamp paper of worth Rs. 200/- A specimen form of agreement is given in the tender documents. **Hard copy of all tender documents should be sent to the tender inviting authority** so as to reach it before the time fixed for tender opening. Otherwise the tenders are liable to be rejected.

9.The successful tenderer should supply the equipments on or before the date specified in the purchase order.


10.The Tender inviting authority will not be responsible for any sort of delay or difficulty faced during the submission of bids through online by the bidders.
