## ORDER No. A1-321/2020/CFS, DATED: 25.01.2021

As per the reference  $1^{\rm st}$  cited Select list of Food Safety Officers eligible for promotion to the cadre of Assistant Commissioner of Food Safety was published.

In the order 2<sup>nd</sup> cited, Sri. P.B Dileep, Food Safety Officer, Ernakulam, and Sri. S.Aji, Food Safety Officer, Thrikkaraka were temporarily promoted to the post of Assistant Commissioner of Food Safety.

The above promotion orders were issued purely on temporary basis since Smt. Jayasree.G, Assistant Commissioner of Food Safety, Sri. K.K.Anilan, Food Safety Officer and Sri. V.K.Pradeep Kumar, Food Safety Officer were served with Memo of charges by Government for major punishment under Rule 15 of the KCS (CC & A), Rules 1960 as recommended by the Vigilance Department.

As per the reference 3 cited, the above said officers are now fully exonerated from the charges levelled against them and Smt. Jayasree. G has been promoted and posted as Deputy Commissioner of Food Safety, South Zone.

In view of the foregoing the following promotion/reversion orders are issued with immediate effect.

In order to exercise the powers conferred by Section i of Section 36 of Food Safety and Standards Act 2006, (Central Act 34 of 2006) the above promoted officers are appointed as Designated Officers for the Revenue District noted against their names and also empowered to compound offences as per Section 69 of the Act.

The incumbents are placed on probation for a period of six months on duty within a continuous service of one year from the date of assuming charge.

The promote officers shall submit their declaration to the Principal Accountant General (A&E) Kerala, Thiruvananthapuram for fixing pay in the cadre of Assistant Commissioner of Food Safety in the scale of pay of Rs.36600-79200. within one month from the date of this order.
